

## How To Handle Workers' Compensation Benefits In Third Party Actions

In the event you are retained to defend a third party tort claim where there is a workers' compensation lien in place, there are a number of considerations that must be processed. Do you want to let a jury know whether or not the Plaintiff has already been compensated? Do you think that by directly informing the jury, they will use this in their deliberations as a basis to start awarding damages, or will they believe the Plaintiff has already received enough for the injury? Would it be a better alternative to allow a jury to speculate whether or not the plaintiff has already received

benefits? There are also practical considerations that require thought. One example of this is how to handle exhibits, depositions, and live testimony that could touch on the subject. Another example is to determine the foundation that is required for admission of bills for related treatment expenses.

In the past, this issue has been addressed by the same District Court Judge in the 6th Judicial District with two divergent rulings that may be of interest to you and helpful in understanding the issues. In a case tried in Cedar Rapids, the issue of the admission of workers compensation benefits was raised by defense counsel to establish an absolute defense to the third party action. Before filing the third party action against his employer and its principals, the Plaintiff had collected approximately \$300,000.00 in medical, temporary total disability, and other benefits as a result of severe burns that occurred at a work site. When presented with a

permanent partial and industrial disability offer, the Plaintiff believed it to be too low. After consulting with counsel, he then claimed he was not an employee so the third party action could proceed. The issue was raised pretrial by a Motion in Limine and addressed during the five days of trial before the case was settled. The rulings received consistently denied the jury access to evidence that workers' compensation benefits had been received at all, let alone the amounts paid. The case was resolved and no appeal was necessary.

More recently in a motion filed in Iowa City, the same defense counsel requested the same judge to deny the jury access to the Plaintiff's receipt of approximately \$140,000.00 in medical, temporary total disability and permanent partial disability benefits. Defense counsel submitted this issue, which was resisted by Plaintiff's counsel and argued that the amount of payments made is admissible on the issue of the reasonable value of medical expenses since *Pexa v. Auto Owners Ins. Co.*, 686 N.W.2d 150 (Iowa 2004), and when admitted, the jury is to be informed that the amount of payments for medical expenses awarded are to be reimbursed to the insurer who paid them. Upon consideration of the rulings raised by defense counsel in *Kuta v. Newberg*, 600 N.W.2d 280 (Iowa 1999); *Loftsgard v. Dorrian*, 476 N.W.2d 730 (Iowa Ct. App. 1991); and *Schonberger v. Roberts*, 456 N.W.2d 201 (Iowa 1990) and Iowa Code § 668.14(2) (2013), the District Court ruled the evidence to be admissible.

The basis on which the Court ruled the payments made were admissible was the reasonable value of medical services could be proven based on *Pexa and Wildner v. Wendorff*, No. 05-1998, 2006 WL 2265453 (Iowa Ct. App. Aug. 9, 2006) (dealing with medical benefits) and 16 Couch on Ins. 3d § 225:175 (2012). The Court further noted that in *Kuta*, the Plaintiff objected to the admission of the evidence of workers' compensation benefits. The Court also ruled that in order to provide confrontation and cross examination

the Plaintiff would need to call a representative from the workers' compensation insurer to lay the foundation for the reasonableness (and presumable necessity) of the payments.

The Court concluded its holding that there could be a limiting instruction on this point to avoid reduction of Plaintiff's recovery because of these payments, without adding that there should not necessarily be an argument by Plaintiff's counsel to award Plaintiff any damages in an amount greater than the lien at the time of trial. There is no doubt that special interrogatories on this subject will be utilized as well. The Court finally found this approach to be the most practical way to proceed because of the substantial references in the

medical records and depositions related to payment of work related benefits.

This case will come to trial in July of 2014. At that point, this issue will be decided by the judge who ruled on the pretrial motion filed by defendant, since he is specially assigned. # IDCA Submits Amicus Brief in Employment Discrimination Case

*Ackelson v. Manley Toy Direct, L.L.C., 832 N.W.2d 678 (Iowa 2013)*

The Iowa Supreme Court has affirmed a district court holding that the Iowa Civil Rights Act does not permit an award of punitive damages except where expressly authorized. The Iowa Defense Counsel Association (IDCA) filed an amicus brief in support of the Appellees, arguing that the principles of stare decisis and legislative acquiescence precluded punitive damages.

The case began when Plaintiffs-Appellants Tammie Ackelson, Robin Drake, and Heather Miller, sued their employer Defendants-Appellees, Manley Toy Direct L.L.C. and Toy Network L.L.C., and asserted claims for sexual harassment, sex discrimination, and retaliation under the Iowa Civil Rights Act (“ICRA”). The employees alleged that a supervisor and a coworker repeatedly engaged in harassing and offensive conduct and sought punitive damages. The employer filed a motion to strike the punitive damages claim, arguing that punitive damages were not permitted by the ICRA. The district court granted the motion, and the employees requested and were granted the right to file an interlocutory appeal. The sole issue on appeal was whether the ICRA permits an award of punitive damages for allegations of employment discrimination.

Plaintiffs-Appellants argued that Iowa law permits punitive damages based on the presence or absence of willful and wanton conduct and not based on the theory of law under which the claims are made. Relying on *McElroy v. State*, 703 N.W.2d 385 (Iowa 2005), Plaintiffs-Appellants argued that not only jury trials were permitted in ICRA claims, but also that all other components of the civil justice system were available and, thus, so should punitive damages be if the requisite willful and wanton conduct was established.

Defendants-Appellees argued that the ICRA was a comprehensive, exclusive and preemptive statutory scheme that provided only a statutory remedy. Because punitive damages were not damages “for an injury caused by a discriminatory or unfair practice”, the ICRA did not authorize the district court to award punitive damages as a remedy. Finally, Defendant-Appellees noted that the Iowa Supreme Court had determined that punitive damages were unavailable in *Chauffeurs, Teamsters & Helpers, Local Union No. 238 v. Iowa Civil Rights Comm’n*, 394 N.W.2d 375 (Iowa 1986), the Iowa legislature had never acted to change that interpretation.

The Iowa Defense Counsel Association submitted an amicus brief expanding on Defendant-Appellees *Chauffeurs* argument, arguing that for twenty-six years the Iowa legislature had

acquiesced in that decision. The IDCA further argued that the Iowa Supreme Court should observe stare decisis and continue to adhere to its precedent. The Iowa Supreme Court agreed.

On June 21, 2013, the Iowa Supreme Court held that punitive damages were not available under the ICRA except when expressly authorized by the Iowa Legislature. The Court reviewed other states’ statutes regarding the availability of punitive damage awards in employment cases and discussed its own precedent regarding the availability of punitive damages under the ICRA. While the Court acknowledged the public policy arguments in favor of permitting punitive damage awards, it ultimately chose to rest its opinion on “the venerable principles of stare decisis and legislative acquiescence.”

We have clearly and repeatedly stated our conclusion that the ICRA does not implicitly permit an award of punitive damages. This message has been a reoccurring pronouncement over the last twenty-seven years. No significant legislative changes have been made since our first pronouncement in 1986 that would even hint at a shift in legislative intent since that time.

. . . .

. . . We did our job twenty-seven years ago and will leave it for the legislature to take any different approach.

. . . [W]e are confident that our legislature has acquiesced in our position after twenty-seven years.


